

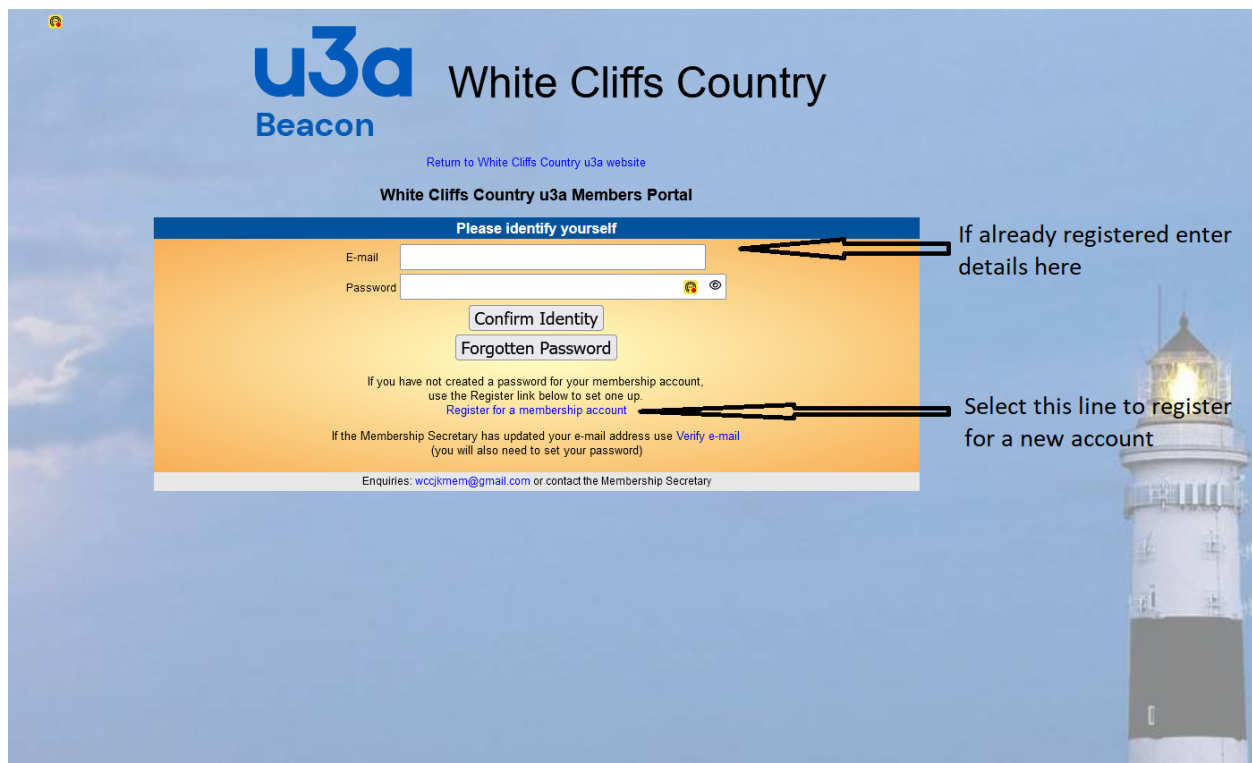
Dear Member

You will Then be taken to the Registration Page and you will need the following information

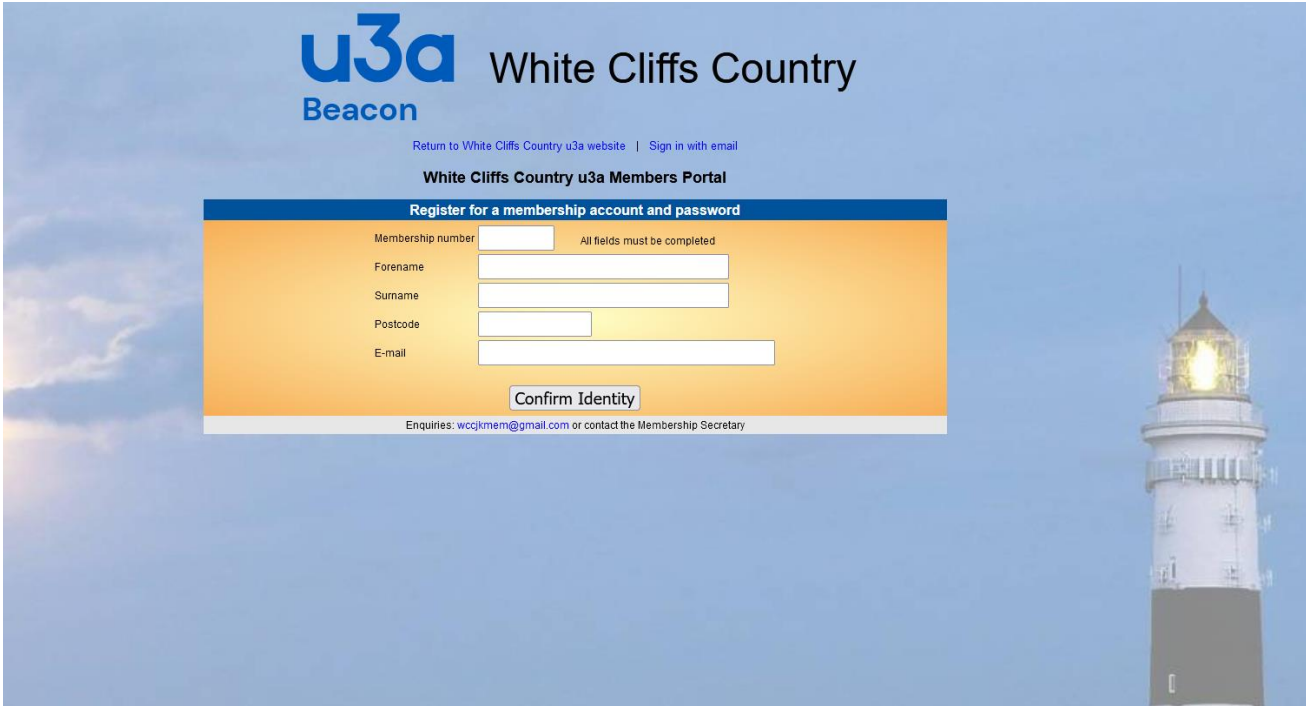

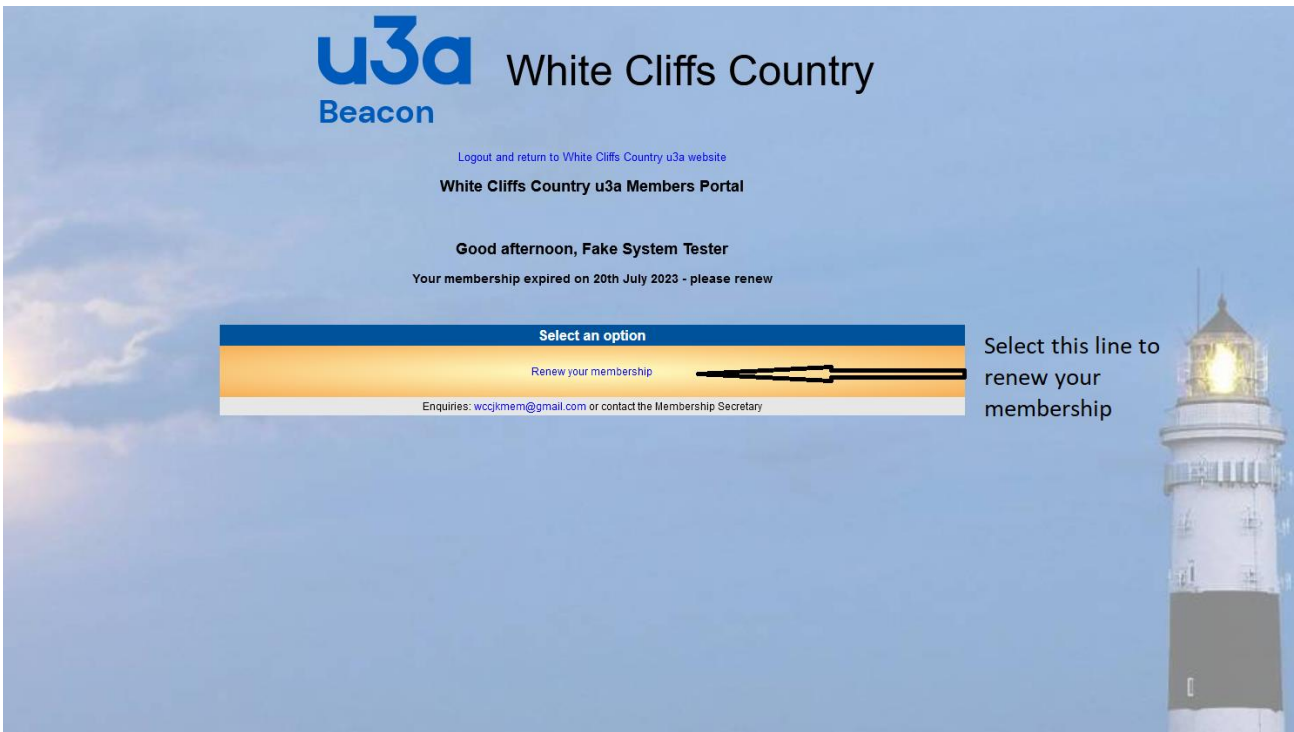

Gift Aid

Your subscription can make each £1 of your subscription worth 25p more and at no cost to yourself. To qualify for Gift Aid you must pay income tax or capital gains tax at least equal to the amount that White Cliffs Country u3a claims on your subscription and donations in a tax year.
